Annex 1 - Mandatory Conditions (as applicable)

- 1. No supply of alcohol may be made under this Premises Licence
 - a) at a time when there is no designated premises supervisor in respect of the Premises Licence, or
 - b) at a time when the designated premises supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under this Premises Licence must be made or authorised by a person who holds a Personal Licence.

Where a Village Hall is exempt from needing DPS under s.19 Licensing Act 2003

Every supply of alcohol under the premises licence must be made or authorised by the Management Committee.

Mandatory condition where the licence authorises the exhibition of films

The admission of children to the exhibition of any film must be restricted in accordance with section 20 of the Licensing Act 2003. Admission of children must be restricted in accordance with any recommendation made by the British Board of Film Classification or the Licensing Authority.

Prohibited conditions: plays

- 1. In relation to a premises licence which authorises the performance of plays, no condition may be attached to the licence as to the nature of the plays which may be performed, or the manner of performing plays, under the licence.
- 2. But subsection (1) does not prevent a licensing authority imposing, in accordance with section 18(2)(a) or (3)(b), 35(3)(b) or 52(3), any condition which it considers necessary on the grounds of public safety.

Mandatory condition: Door supervision

Each individual engaged in security activities at the premises must either:

- a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
- b) be entitled to carry out that activity by virtue of Section 4 of the Private Security Industry Act 2001.

LICENSING ACT 2003 (MANDATORY LICENSING CONDITIONS)(AMENDMENT) ORDER 2014

MANDATORY CONDITIONS

Condition 1

- 1. The responsible person must ensure that staff on relevant premises no not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:
 - a) Games or other activities which require or encourage, or are designed to require or encourage individuals to
 - i. Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. Drink as much alcohol as possible (whether within a time limit or otherwise);

- b) Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c) Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) Dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Condition 2

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Condition 3

- 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
 - a) A holographic mark, or
 - b) An ultraviolet feature

Condition 4

The responsible person must ensure that -

- a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - i. Beer or cider: ½ pint;
 - ii. Gin, rum, vodka or whisky: 25ml or 35ml; and
 - iii. Still wine in a glass: 125ml;
- b) These measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1—

a) 'duty' is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

b) 'permitted price' is the price found by applying the formula-

$$P = D + (D \times V)$$

Where —

i. P is the permitted price,

ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:

- c) 'relevant person' means, in relation to premises in respect of which there is in force a premises licence
 - i. the holder of the premises licence.
 - ii. the designated premises supervisor (if any) in respect of such a licence, or
 - iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d) 'relevant person' means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- e) 'valued added tax' means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the Operating Schedule

- The Premises Licence Holder shall ensure that the DPS/Manager fully complies with the conditions of this Premises Licence and takes all reasonable measures to promote the licensing objectives whenever Licensable Activities take place at the Licensed Premises.
- The Premises Licence Holder shall be responsible for the management of events to ensure that no nuisance is caused to residents who live in the vicinity of the Licensed Premises.
- 3. The Premises Licence Holder shall operate the premises in accordance with:
- a. noise levels agreed with the Environmental Protection Department in conjunction with the Licensing Team of Cheshire East Council. Where the Premises Licence Holder and Environmental Protection Department cannot agree the limit Licensing Authority shall be the final arbiter;
- b. an Event Management Plan which shall cover the roles and duties of security staff and stewarding, noise management, traffic management, dispersal, CCTV, signage, post-event clean-up and anti-social behaviour and shall be approved by the Licensing Authority. Staff shall be fully briefed to understand their duties.
- 4. Local Residents within an area designated by the Licensing Authority (but covering at least Beggar Man's Lane between Bexton Lane and Highland Way, and Bexton Lane south of Valley Way) shall be given at least 4 weeks prior notice by the Premises Licence Holder of wedding events at the Licensed Premises and at least 2 weeks notice for all other events where amplified music or amplified voices are to be played, save in exceptional circumstances e.g. funerals where notice shall be provided to local residents upon confirmation of booking. Notice shall be deemed to have been given by publication on the Licensee's website, full details of which (including login details if password protected) shall be provided to the defined local residents.
- 5. The Premises Licence Holder/DPS will ensure that their contact details (to include email address, landline and mobile telephone number) are available on the website. The nominated mobile phone number shall be to a phone which is being monitored within the Licensed Premises whenever licensable activity is taking place.
- 6. The Premises Licence Holder shall ensure that all complaints received are be logged and the actions taken to address complaints shall be recorded in the log. The log shall be available for inspection by the Licensing Authority or Police upon request.

9. Music performed by live bands and performers shall cease by

- 10. Frequency of Events:
- a. There shall be no consecutive events where amplified music/amplified voices are played where one of those events takes place on a Monday to Thursday inclusive. (For the avoidance of doubt this means that if there is an event on a Thursday, there shall not be an event on a Wednesday or a Friday).
- b. In any three-week period throughout the year there shall be one weekend where there are no consecutive events on a Friday, Saturday and Sunday.
- c. The premises licence holder shall publicise on their website and notify hirers of the licensed premises of the terms of the licence, including the licence conditions and all policies of the premises licence holder prior to accepting a booking.
- 11. The Premises Licence Holder shall maintain an in-house sound system/PA system which shall include a compressor/limiter and be used for all performances of live and recorded music (save as detailed below in respect of drums) and for speeches and announcements using microphones. The initial installation of the system shall be in accordance with the

specification as agreed between Mr. Dani Fiumicelli of Temple Acoustics and Mr. Donald Quinn of Hepworth Acoustics. In the absence of agreement, the Environmental Protection Department of Cheshire East shall be the final arbiter

- 12. The electronic compressor/limiter referred to above shall be set at a level agreed with the Licensing Authority.
- No acoustic drums are to be played at any event, save that in 2020 there may by up to five events where such use is permitted (providing those events have been booked before 31st March 2020). Electronic drums may be used, the sound of which is to be played through the in-house sound system,
- 14. Recorded music played by DJs shall be permitted until the relevant terminal hour. Thirty minutes before the end of the time permitted for the provision of regulated entertainment the music levels shall be gradually reduced to a lower volume and tempo.
- 15. When playing amplified music, all bands and/or DJs are to be located no closer to the party wall than in the alcove area of the Lodge.
- 16. The Premises Licence Holder shall comply with all reasonable instructions given by the Licensing Authority and/or Environmental Protection Team of the Council that seek to control noise nuisance.
- 17. During any events where amplified music/amplified voices are being played the venue doors (including fire doors) shall be kept closed (except when in use for access and egress to and from the premises). The operation of the doors shall be monitored by security/stewards throughout events when amplified music/voices are being played.
- 18. The windows at the premises shall not be opened during any event involving regulated entertainment.
- 19. No amplified music or voices are to be used in the Bowling Green/garden area at any time.
- 20. The Premises Licence Holder shall construct a solid or substantially solid fence of at least 1.8m high along the southern perimeter and at least 1.2m high along the western perimeter of the Bowling Green/garden area. Access to that area shall be through a lockable gate from the car park area on the southern perimeter. The Bowling Green/garden area shall not be accessible to customers after 20:00 hrs and is to be monitored after that time to ensure that no-one enters that area.
- 21. From 20:00 hrs onwards, the car park and driveway shall be monitored by staff/security staff to ensure that customers do not cause a nuisance.

- 22. A fence is to be constructed around the patio area constructed in line with the eastern edge of the acoustic porch with a gated entrance at the southern corner of the patio. This is to be manned at all times by security staff when licensable activities are taking place in the Lodge after 20:00 hrs.
- 23. No alcohol is to be taken outside the fenced patio area after 20:00 hrs.
- 24. The smoking area shall be designated at the rear of the premises so that no nuisance is caused and shall be managed by security/stewarding staff.
- 25. Drop off and pick up
- a. The designated taxi pick-up and drop-off area shall be situated on the driveway to the south of the premises so that no nuisance is caused and shall be managed by security/stewarding staff.
- b. Appropriate signage shall be erected to direct the flow of taxis and other traffic to the correct location for drop off and collection of customers.
- c. Customers using a taxi service once the amplified music and voices have ceased shall exit the premises by the door to the west of the premises.
- d. No pick up or drop off of passengers is to take place in the area to the East of the main door, save for those arriving or departing in a private vehicle parking in the car park.
- 26. Staff shall be trained to understand the importance of promoting the licensing objectives, preventing noise nuisance and anti-social behaviour, and reminding guests to exit and depart from the Licensed Premises quickly and quietly out of respect for neighbours. Such training is to be documented and records of training will be kept and made available to the Police and Licensing Authority upon request.
- 27. External lights shall be extinguished no later than 15 minutes after the closure time of the Licensed Premises.
- 28. The setting up and taking down of events shall only take place between the hours of 08:00 to 20.00 hours Monday to Sunday, save for the removal of live performers' equipment and DJ equipment which must be removed within thirty minutes of the terminal hour for the conclusion of regulated entertainment.
- 29. There shall be no emptying of bottles by staff into external bins or receptacles after 20:00 hours or before 09:00 hours.

- 30. The number of guests at events when Licensable Activity takes place shall be limited to 180.
- 31. A porch area shall be maintained between the exterior of the premises and the fire doors to the west of the premises (the main entrance/exit), including triple glazed acoustic self-closing doors. This entrance/exit will be orientated so that patrons leave the premises in a southerly direction.
- 32. No fairground attractions are to be used at the premises, including the Bowling Green and car park.
- 33. No fireworks (including hand-held fireworks) are to be used or discharged at the premises, including the Bowling Green and car park.
- 34. A gate will be maintained at the Lodge end of the driveway at the point where the drive opens out into the car park area. Access and egress of vehicular and pedestrian traffic will be controlled by security staff from at least one hour before the end of the event (or 22:00 hours, whichever is later) until all customers have left. Customers will be directed not to walk along the driveway save for access and egress.
- 35. There shall be no more than 5 outdoor wedding ceremonies held at the premises in any given calendar year.
- 36. No festoon lighting shall be utilised on the driveway to the premises opposite the residential property which shares a party wall.
- 37. There shall be no tent/marquees or similar temporary structures erected outside the premises save for on one occasion in 2020 (to cater for an event which has already been booked, providing that this event finishes outside before 22:30 hrs. The restriction on alcohol being taken outside the patio area after 20:00 hrs is also extended to 22:30 hrs on this one occasion)
- 38. Where work is required to be done by the Premises Licence Holder in order to comply with these conditions, there shall be a lead-in period of 12 weeks from the date on which these conditions come into force to allow such work to be carried out. During that time, the Premises Licence Holder will be deemed to not be in breach of these conditions if the required work has not been completed.
- 39. A CCTV camera with a recording facility to a specification agreed with the Licensing Authority is to be located outside the premises to cover the car park and Bowling Green area but is not to cover the adjoining residential property. Recordings are to be retained for

28 days and are to be made available on request to either the Police or a Licensing or Environmental Health officer.

40. The fence erected outside the windows of the adjoining residential property (to the right of the driveway when approaching the car park) is to be removed and replaced with picket/ranch style fencing (as is currently in place to delineate the Bowling Green on the opposite side of the drive).

Licensing Act 2003 - Premises Licence

Duration of a Premises Licence

A premises licence has effect until such a time that it is suspended, revoked or surrendered.

Duty to notify change of name or address

The holder of a premises licence must, as soon as is reasonably practicable, notify the relevant licensing authority of any change of name or address.

Where the designated premises supervisor (DPS) under a premises licence is not the holder of the licence, he should notify the licensing authority of a change in name or address as soon as possible. The DPS must also notify the holder of the premises licence.

Failure without reasonable excuse to comply with the above is an offence, and a person will be liable on summary conviction to a fine not exceeding level 2 on the standard scale (ie£500)

Duty to keep and display licence

The holder of a premises licence must ensure that the licence or a certified copy of it is kept at the premises in the custody of or under the control of the holder of the licence or a person who works at the premises whom the premises licence holder has nominated in writing. A notice should be prominently displayed at the premises specifying the position of any such nominee.

The premises licence holder has a duty to ensure that a summary of the licence or a certified copy of that summary is prominently displayed at the premises.

Failure without reasonable excuse to comply with the above is an offence, and a person will be liable on summary conviction to a fine not exceeding level 2 on the standard scale (ie £500)

Duty to produce licence

A constable or an authorised person may require production of the premises licence for examination. An authorised person must, if requested, produce evidence of his authority to exercise the power.

Failure without reasonable excuse to comply with the above is an offence, and a person will be liable on summary conviction to a fine not exceeding level 2 on the standard scale (ie £500)

Theft or loss of premises licence

Where a premises licence or summary is lost, stolen, damaged or destroyed, the holder of the licence may apply to the relevant licensing authority for a copy of the licence or summary. A fee of £10.50 is payable in relation to such an application.

Where an application is made for a replacement licence or summary the licensing authority must issue the holder of the licence with a licence or summary if it is satisfied that –

(a) the licence or summary has been lost, stolen, damaged or destroyed; and

(a) where it has been lost or stolen, the holder has reported that loss or theft to the police.

Surrender of premises licence

Where the holder of a premises licence wishes to surrender his/her licence he/she may give the licensing authority a notice to that effect. The notice must be accompanied by the premises licence, or where that is not practicable, by a statement of the reasons for the failure to provide the licence. Where a notice of surrender is given, the premises licence lapses on receipt of the notice by the licensing authority.

Death, incapacity, insolvency of licence holder

A premises licence lapses if the holder of the licence -

- (a) dies.
- (a) becomes mentally incapable (within the meaning of section 13(1) of the Enduring Powers of Attorney Act 1985)
- (b) becomes insolvent,
- (c) is dissolved, or
- (d) if it is a club, ceases to be a recognised club

(subject to provision for re-instatement in certain circumstances).

S.57 Duty to keep and produce licence

- (2) The holder of the premises licence must secure that the licence or a certified copy of it is kept at the premises in the custody or under the control of-
 - (b) a person who works at the premises and whom the holder of the licence has nominated in writing for the purposes of this subsection
- (3) The holder of the premises licence must secure that-
 - (b) a notice specifying the position held at the premises by any person nominated for the purposes of subsection (2), are prominently displayed at the premises.
- (4) The holder of a premises licence commits an offence if he fails, without reasonable excuse, to comply with subsection (2) or (3).
